Pastor Jay Peach, from the Faith Center, gave the invocation. Mayor Nancy Malone led the flag salute. Mayor Malone called the Regular Meeting of the Kelso City Council to order. Councilmembers in attendance were Jeffrey McAllister, Mike Karnofski, Kim Lefebvre, Richard McCaine, Keenan Harvey, Lisa Alexander, and Nancy Malone.

Minutes: Upon motion by Councilmember Lefebvre, seconded by Councilmember Harvey, 'Approve the Minutes of the 2/16/21 Regular Meeting,' motion passed, all voting yes.

### **CITIZENS BUSINESS:**

**Kevin Rentner**, from the Washington Department of Corrections, spoke about the proposed ordinance agenda item limiting the amount of sex offenders living at the same residence. Mayor Malone ask Mr. Rentner to stay for the discussion portion of the proposed ordinance slotted later in the agenda.

### **COUNCIL BUSINESS:**

Discussion – Ordinance Proposal Limiting the Number of Registered Sex Offenders and Convicted Felons Residing at the same Location: Councilmember Harvey spoke about a 2017 article from the local newspaper that showed that Cowlitz County had the highest rate of sex offenders per capita in the state. He commented that his concern was that Kelso received more registered sex offenders transferring from prison to the community, through Senate Bill 6157, because Kelso had more affordable housing available than the neighboring communities. Lengthy discussion followed. Upon motion by Councilmember Harvey, seconded by Councilmember Alexander, 'Direct Staff to bring back a draft ordinance, similar to the City of Puyallup ordinance, allowing for only two sex offenders to reside in one location.' Discussion continued. Upon motion by Councilmember Lefebvre, seconded by Councilmember Karnofski, 'Table the motion'. Discussion regarding procedure followed. Upon motion by Councilmember Lefebyre, seconded by Councilmember Karnofski, 'Withdraw the motion to table, and motion to postpone it indefinitely.' Discussion continued. Councilmember Karnofski called for the question. Mayor Malone reiterated the motion, 'Postpone the Motion Indefinitely'. Councilmembers Karnofski, Lefebvre, McCaine, and Malone voted ves. Councilmembers McAllister, Harvey, and Alexander voted no, motion passed, 4 to 3. Discussion followed. The consensus of the Council was to hold a special meeting, in a workshop format, on March 9<sup>th</sup>, at 6:30 PM, via Zoom, to allow time for staff to provide information for further discussion toward drafting a document regarding registered sex offenders residing at the same location.

### **MOTION ITEMS:**

Upon motion by Councilmember Lefebvre, seconded by Councilmember Alexander, 'Pass on 1st reading, 'AN ORDINANCE OF THE CITY OF KELSO, WASHINGTON AMENDING KELSO MUNICIPAL CODE CHAPTER 10.12 TO AMEND TIME PERIODS FOR PUBLIC PARKING ON CITY STREETS AND CITY PROPERTY,' motion passed, all voting yes.

Ordinance No. (1st Reading) Authorizing and Approving a Loan Agreement for the Cost of Fuel Farm Improvements at the Southwest Washington Regional Airport: The Deputy Clerk read the proposed ordinance by title only. Upon motion by Councilmember Karnofski, seconded by Councilmember Lefebvre, 'Pass on 1st reading, 'AN ORDINANCE OF THE CITY OF KELSO, WASHINGTON AUTHORIZING AND APPROVING A LOAN AGREEMENT BETWEEN THE WASHINGTON STATE COMMUNITY AVIATION REVITALIZATION BOARD AND THE CITY OF KELSO FOR AID IN FINANCING THE COSTS OF FUEL FARM IMPROVEMENTS AT THE SOUTHWEST WASHINGTON REGIONAL AIRPORT,' motion passed, all voting yes.
