<u>Consideration of School District Request to Help Fund Allen Street Traffic Lights:</u>
Roy Parsons, President of the Kelso School District Board of Directors, spoke about the traffic problems on Allen Street near Kelso High and Coweeman Middle School and asked the Council to assist with funding.

Jim Biwer, Executive Director of Support Services, said after working with three engineers, it was determined installing traffic lights was the best option for pedestrians.

Councilmember Wheeler arrived at 7:13 p.m.

Council discussion followed.

Patty Wood, Vice President of the Kelso School District Board of Directors, stated pedestrian safety is the School District's main concern not only during school, but after school as well.

Mayor Gregory stated Columbia Security, who has been patrolling at the school, will be terminating their contract soon. Further discussion followed.

**Jim Biwer** asked if the City would maintain the traffic signals. Public Works Director David Sypher stated currently the City pays for the maintenance of traffic lights but contracts with the State to maintain them.

**Diane Dick, Kelso School Board Member**, spoke from the audience stating the residents of Kelso are feeling the stress of the increased traffic due to new development east of the high school.

Mayor Gregory thanked the Kelso School Board Members for attending the Council Meeting.

Council discussion followed. Approval to Consider a Change to the Comprehensive Plan Along with a Concomitant Zone Change: Upon motion by Councilmember Futcher and seconded by Councilmember McDaniel, 'Approve the recommendation of the Planning Commission to amend the comprehensive plan.' Discussion followed. Interim Senior Planner Norm Gollub answered some questions concerning the vicinity maps in the handout given to Councilmembers.

<u>Ye-Ping Chin of PFC Development Corporation</u>, presented drawings of the facility PFC plans to build at the old juvenile detention center in North Kelso.

Motion carried, all voting yes.

Resolution No. 07-939 – Authorizing Obligation of \$216,250 Federal Aid Funds for the Yew Street Reconstruction Project: The City Clerk read the proposed Resolution by title only. Upon motion by Councilmember Wheeler and seconded by Councilmember McDaniel, 'Approve Resolution No. 07-939, 'A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELSO AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH WSDOT FOR PROJECT EXPENDITURE FOR THE YEW STREET RECONSTRUCTION PROJECT.' Public Works Director David Sypher explained the project. Discussion followed. Motion carried, all voting yes.
