Stormwater Advisory Committee Meeting

September 28, 2011

Call to Order:

Dan Howell called the meeting to order at 4:03 p.m., at City of Kelso City Hall, 203 S. Pacific Ave., Conference Room 203.

Approval of Minutes:

No quorum at July 13, 2011 meeting therefore no minutes to approve. Gary Fredricks made the motion, seconded by Gloria Nichols to approve the minutes of June 29, 2011. Motion carried, all in favor.

New Business:

1. Illicit Discharge Program

IDDE Program document is based upon Longview's document and uses the approved permit requirements. This document summarizes the entire illicit discharge program. IDDE is a subset of the Stormwater Management Program. We are trying to work together with Longview and the Diking Districts as a combined effort.

Each section of the program was reviewed and discussed by Van McKay.

Add question to section III Elimination - 'Have preventative measures been taken to prevent spill from spreading further?'

Pipe Camera option was discussed for viewing stormwater lines – there is no budget at this time so we will continue using Operations and the current equipment.

This document has been requested to be taken to Council for their information and approval and to let them know the KSAC has approved this document as policy and procedure for the Illicit Discharge portion of the NPDES Permit.

Gary Fredricks made a motion and Steffanie Taylor seconded that the document be approved. Motion carried, all in favor

2. Education Interlocal Agreement

This document is to be reviewed and revised as necessary. Revisions have been made to more closely reflect what we are actually doing. The original document focused on a telephone survey in the area. The revised document reads to be more general in market research. It also adds that all entities can work together and share costs in education projects. Two or more parties can participate – does not have to include all entities each time.

Although Kelso's City Council has already approved the changes to this document, Longview's City Attorney has made some revisions that were just presented yesterday so we will need to make these changes and bring it back to the Kelso City Council for approval of these changes.
